ORDER AND ADJUDGED, that the New York Liquidation Bureau is authorized to receive and disburse to Kaiser Foundation Hospitals any future distributions received without further application to this Court; and it is further

ORDERED AND ADJUDGED, that the Liquidator is authorized and directed to destroy or otherwise dispose of any and all of the books, files, records and other property of CHP, without further order of this Court.
