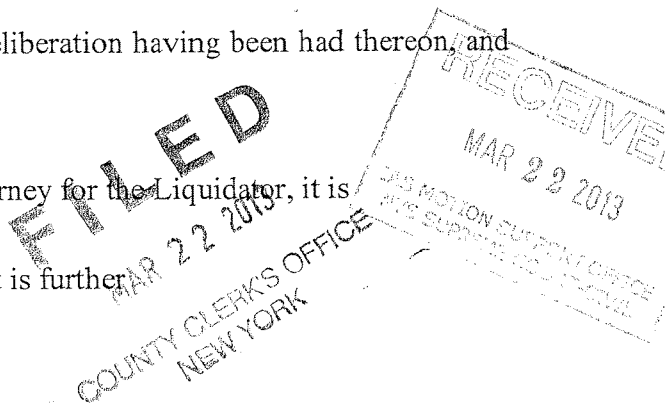


NOW, on application of John Pearson Kelly, attorney for the Liquidator, it is
