Upon the August 12, 2021, affirmation of David Axinn ("Axinn Aff"), Special Deputy of the New York Liquidation Bureau ("NYLB") and Agent of Linda A. Lacewell, Superintendent of Financial Services of the State of New York in her capacity as liquidator ("Liquidator") of American Medical and Life Insurance Company ("AMLI") and its attachments, and upon all other papers previously submitted and all proceedings heretofore had herein;

NOW, on motion of the Liquidator, and after due deliberation having been had thereon,

LET all claimants and all interested in the affairs of AMLI show cause before the Court at 304IAS Part 56, Room 3/1, 71 Thomas Street, New York, NY 10013 on the 21 day of <u>SEPTEMBER</u> 2021 at  $30^{\circ}$  clock A.m. ("Return Date") or as soon thereafter as counsel can be heard, why an order substantially in the form of the proposed order attached as Exhibit A to the Axinn Aff, should not be made approving the Liquidator's recommendation and allowing the omnibus claim filed by the National Organization of Life and Health Insurance Guaranty Associations ("NOLHGA") in the amount of \$60,000 as a Class Four claim against the AMLI estate under New York Insurance Law Section 7435(a)(4);

AND, sufficient cause having been alleged therefor it is hereby

Glover, Esq., located at 1144 15<sup>th</sup> Street, Suite 3400, Denver, Colorado 80202, attorneys for the 39 State Guaranty Associations asserting claims as part of the omnibus claim at issue on this motion; and it is further

ORDERED, that a copy of answering papers, either in support of or opposition to the relief sought herein ("Answering Papers"), shall be served on the Liquidator at the following address:
