

**IN THE MATTER OF THE LIQUIDATION OF
EVEREADY INSURANCE COMPANY

NOTICE

The Acting Superintendent of Financial Services of the State of New York as liquidator (“Liquidator”) of Eveready Insurance Company (“Eveready”) and administrator (“Administrator”) of the New York Property/Casualty Insurance Security Fund or Public Motor Vehicle Liability Security Fund (collectively, “Security Funds”) in connection with the liquidation proceeding of Eveready has been directed to take possession of Eveready’s property and liquidate its business and affairs pursuant to Article 74 of the New York Insurance Law (“Insurance Law”). The Liquidator has, pursuant to Insurance Law Article 74, appointed Scott D. Fischer, Special Deputy Superintendent (“Special Deputy”), as her agent to liquidate the business of Eveready. The Special Deputy carries out his duties through the New York Liquidation Bureau, 110 William Street, New York, New York 10038. The Acting Superintendent has submitted to the Court a verified petition (“Verified Petition”) seeking an order: (i) approving a procedure for judicial review of the Administrator’s rejection of claims under Eveready policies in this proceeding which are presented for payment from the Security Funds; (ii) appointing a referee to hear and take evidence on issues raised by the claimants’ objections, and to report thereon; and (iii) granting such other and further relief, as this Court may deem just and proper under the circumstances.

A hearing is scheduled on the Verified Petition on the 16th day of March, 2016, (“Return Date”) at 11:30 a.m., before the Court at the Courthouse, IAS Part 42, 111 Centre Street, Room 1127B New York, New York. If you wish to object to the Verified Petition, you or your counsel must serve a written statement setting forth your objections and all supporting documentation (“Answering Papers”) upon the Superintendent at least twenty-one (21) days prior to the Return Date. and by submitting copies of the Answering Papers to the Clerk of the Court at IAS Part 42 at the Courthouse located at 111 Centre Street, Room 1127B, New York, New York at least fourteen (14) days before the Return Date.

The Liquidator’s application is available for inspection at the above address. In the event of any discrepancy between this notice and the documents submitted to Court, the documents control.
