Upon the June 29, 2021, affirmation of Donald N. Cohen ("Cohen Aff"), Special Counsel of the New York Liquidation Bureau ("NYLB"), which serves as the staff of the Superintendent of Financial Services of the State of New York in her capacity as liquidator ("Liquidator") of Quality Health Plans of New York, Inc. ("QHPNY"), ^{dated June 29, 2021} and its attachments, and upon all other papers previously submitted and all proceedings heretofore had herein;

NOW, on motion of the Liquidator, and after due deliberation having been had thereon,

LET all claimants and all interested in the affairs of QHPNY, ^{or their counsel} show cause before the Court at IAS Part 59, ~~Room 331~~, 60 Centre Street, New York, NY 10007 on the ^{25th} day of ^{August} 2021 at ~~___~~ o'clock ~~___~~ m. ("Return Date") or as soon thereafter as counsel can be heard, ^{by submission only} why an order substantially in the form of the proposed order attached as Exhibit 2 to the Cohen Aff, should not be made approving, in accordance with Insurance Law Section 7428, an Assignment of Claims Agreement (the "Assignment Agreement") between the Liquidator and Northwell Health, Inc.

("Northwell), attached as Exhibit 1 to the Cohen Aff., assigning to Northwell certain claims and causes of action belonging to QHPNY;

AND, sufficient cause having been alleged therefor it is hereby

ORDERED, that the Liquidator shall give notice of this application by: (i) posting this Order to Show Cause and its supporting papers on the NYLB Internet web page at <http://www.NYLB.org/QualityHealth.htm> at least ten (10) days before the Return Date; and (ii) publishing the notice substantially in the form attached as Exhibit 3 to the Cohen Aff in the *New York Post* and the *New York Daily News* within twenty (20) days following the date of issuance of this Order to Show Cause; and it is further

ORDERED, that a copy of Answering Papers, either in support of or opposition to the relief sought herein ("Answering Papers"), shall be served on the Liquidator at the following address:
