without further order to this Court, to receive and disburse assets of Transtate after the termination of the Liquidation Proceeding and to use such assets, first to pay administrative expenses incurred in connection with the collection and disbursement of such additional assets, and then to distribute the balance of such assets to those creditors of Transtate with allowed claims who are eligible to share in a *pro-rata* distribution; (vi) approving the Liquidator's recommendation to allow the claim of the New York Property/Casualty Insurance Security Fund ("PC Fund") for a loss it paid on September 10, 2014 totaling \$15,000.00; (vii) releasing and discharging the Liquidator, his predecessors and successors in office, and their agents, attorneys and employees, from any and all liability arising from their acts or omissions in connection with the Liquidation Proceeding; (viii) authorizing and directing the Liquidator, in his discretion, to destroy or otherwise dispose of any and all of the books, files, records and other property of Transtate without further order of this Court; and (ix) providing for such other and further relief as this Court deems appropriate and just.

NOW, upon reading the Verified Petition, dated September 30, 2014, due proof of service thereof upon all parties interested in Transtate, and due deliberation having been had thereon, and upon the decision of this Court;

NOW, on application of John Pearson Kelly, attorney for the Liquidator, it is ORDERED, that the application is granted; and it is further

ORDERED, that the Closing Report on the status of and request to close the Liquidation Proceeding and the financial transactions delineated such Closing Report are approved; and it is further

ORDERED, that the Liquidator is authorized to continue paying administrative expenses, including such expenses pertaining to the closing of the Liquidation Proceeding; and it is further

ORDERED, that the Liquidation Proceeding is terminated and closed; and it if further

ORDERED, that the Liquidator is authorized to pay from the WC Fund, after the termination of the Liquidation Proceeding, any additional workers' compensation claims demonstrated to be subject to payment by the WC Fund pursuant to Article 6-A of the Workers' Compensation Law that may arise under policies previously issued by Transtate, and to pay administrative expenses incurred in connection with the payment of such workers' compensation claims, without further order of this Court; and it is further

ORDERED, that the Liquidator is authorized, without further order to this Court, to receive and disburse assets of Transtate after the termination of the Liquidation Proceeding and to use such assets, first to pay administrative expenses incurred in connection with the collection and disbursement of such additional assets, and then to distribute the balance of such assets to those creditors of Transtate with allowed claims who are eligible to share in a *pro-rata* distribution; and it is further

ORDERED, that the Liquidator's recommendation to allow the claim of the PC Fund for a loss it paid on September 10, 2014 totaling \$15,000.00 is approved; and it is further

ORDERED, that the Liquidator, his predecessors and successors in office, and their agents, attorneys and employees, are released and discharged from any and all liability arising from their acts or omissions in connection with the Liquidation Proceeding; and it is further

ORDERED, that the Liquidator, in his discretion, is authorized and directed to destroy or otherwise dispose of any and all of the books, files, records and other property of Transtate without further order of this Court.
